## DANCE - STUDENT CONTRACT

### 1. Location:

All lessons, classes, and events will take place at Songbirds Music, Art, & Dance Center located at 181 E Mitchell Hammock Rd, Oviedo, FL. 32765

### 2. Tuition:

- a. Songbirds Music, Art, & Dance Center **does not charge any registration fees.**
- b. Classes are offered weekly either as 30 min, 45 min, 60 min, or 90 min classes. **Classes regularly run from August- May.** Selected classes will also be offered during summer months.
- c. **Classes are charged for at the beginning of the month.** Pricing is as follows:
  - First 30 min weekly class - \$40/ month
  - First 45 min weekly class - \$50/ month
  - First Hour Long weekly class - \$60/ month
  - Additional Hour-Long weekly classes - +\$45/ month
  - Any more Additional Hour-Long weekly classes - +\$30/ month
  - 90 min weekly class - \$84/ month
- d. Siblings with multiple family members enrolled, or individuals enrolled in both music lessons and dance, will receive the sibling discount on dance classes. Sibling pricing for dance is as follows:
  - First 30 min weekly class - \$35/ month
  - First 45 min weekly class - \$45/ month
  - First Hour Long weekly class - \$55/ month
  - Additional Hour-Long weekly classes - +\$40/ month
  - Any more Additional Hour-Long weekly classes - +\$25/ month
  - 90 min weekly class - \$79/ month
- e. **Monthly tuition is the same every month regardless of the number of classes held.**
- f. We generally base our calendar off the Seminole County School District Calendar- we are not closed every single day they are. A Songbirds Calendar can always be found available in the lobby or online.
- g. **All students are required to enroll in our secure auto-bill system.** This is a safe, secure and convenient way to pay your ongoing tuition. We accept Visa, MasterCard, Discover, AMEX, Check Cards, and ACH (bank draft).
- h. **Payment is automatically processed on the first of each month.** An email reminding you of the automatic draft will be sent by the system every time your card is charged.
- i. Failure to complete payments regularly and on time may result in penalties and revision of this contract.
  - i. Late payments will incur a late fee of \$10 after 10 days past due. It is the responsibility of the student or guardian to ensure current payment information is on file.
- j. **Please note, when registering for dance classes, you are registering for the dance class for the entire school year (August- May) or entire summer (June- August). To withdrawal early, please see our withdrawal policy (section 6).**

### 3. Attire and Materials:

- a. **All students are required wear the proper dance attire, including shoes, for every class.**
- b. Hair must be worn up and out of faces.
- c. All students are expected to bring water to every class.

### 4. Referral Incentives:

- a. Songbirds Music, Art & Dance Center puts a \$10 referral credit onto your account when you refer us a new student! The credit will be placed on your account and be automatically used towards your next payment.
- b. The new student must tell us your name upon registration.

5. Makeup Policy:

- a. Dancers are allowed **one makeup class per semester over Zoom. If the student is unable to attend their regularly scheduled class via zoom, a recording can be made with at least 24 hrs notice.**
- b. Makeups will only be given to students who have given prior notification to the instructor and administration, and whose accounts are up to date.
- c. **Our staff and instructors retain the right to send a student home, without refund, should they arrive visibly ill.**
- d. **If a class needs to be cancelled due to an instructor's schedule or circumstances of Songbirds Music, Art, & Dance Center, a credit will be offered.**

6. Withdrawal Policy:

In order to early withdrawal from dance classes (any time before MAY), formal notice must be completed. Official notice must be made through our online form: [www.SongbirdsOviedo.com/Cancel](http://www.SongbirdsOviedo.com/Cancel) **Notice must be submitted once month in advance from the student's expected withdrawal date.** Once the notice has been submitted, the student's account will be charged one additional month and is permitted to take their regularly-scheduled classes for the month(s) paid for. (ie- student gives notice on Feb 15<sup>th</sup>. Account is charged on March 1<sup>st</sup>, and last day of that's student's class is March 31<sup>st</sup>). Our season runs August- May.

7. Media and Press Release

By agreeing to this contract, you give permission to Songbirds Music, Art, & Dance Center to record you and/or the student via audio recording, film recording, pictures, and other media during a live performance, lesson, or other event sponsored by Songbirds Music, Art, & Dance Center. You consent that these recordings and various media may be used in print, on the internet, and for any form of media purposes. They may be used for marketing, promotion of the school, or advertisements. You release Songbirds Music, Art, & Dance Center from all claims, demands, liabilities, and damages whatsoever in connection with the media usage of myself or the student under my care.

Not agreeing to this clause will not have any adverse effect on lessons or instruction at Songbirds Music, Art, & Dance Center. We do not have full control of media from recitals, so students who are unable to be recorded should not participate in recitals.

8. Release of Liability

I, the student or the student's guardian, understand that there may be inherent dangers in the performing arts. Partaking in music instruction, dance instruction, art instruction, or any event at Songbirds Music, Art, & Dance Center may result in personal injury, accidents, or even death. I understand that Songbirds Music, Art, & Dance Center is insured in case of accident and will do everything in its power to provide a safe place for myself and/or my student. I release Songbirds Music, Art, & Dance Center from all claims, demands, liabilities, and damages whatsoever in connection with the above.

9. By registering for classes, you understand and agree that:

- a. As the student and/or parent/legal guardian of the student(s), you acknowledge that you have voluntarily elected to enroll in lessons at Songbirds Music, Art, & Dance Center.
- b. You have read and understood all terms of this contract.
